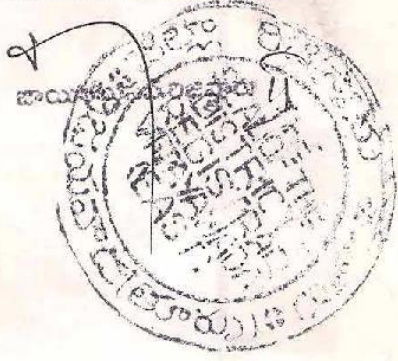

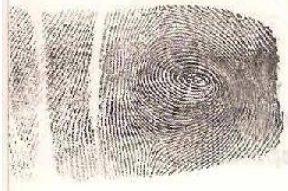

- h. To undertake propaganda training and education of the masses either of its own or in co-operation with similar agencies working for the cause of all round development of the Society
- i. To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objectives of the Trust
- j. To function as a Non-Communal Trust and as a Secular Organisation
- k. To capacitate grassroots level ngos in better organizational management and project implementation skills
- l. To support ngos working with the same mission of the trust
- m. To act as consultant and nodal organization to ngos within and outside India
- n. For the carrying out and execution of the mentioned objects, the Trust may acquire properties, movable and immovable, or the proceeds thereof, all funds, gifts and surpluses in constructed or landed properties, in securities and shares, bank deposits included, of every description and to negotiate the same in any way whatsoever.

## 2. NUMBER OF TRUSTEES

The Number of Trustees including the Founder Trustees shall not be less than five and not more than nine persons. The Board of Trustees shall nominate and invite persons to be the other trustees for such period, as they may deem fit and proper.

### 3. PROPERTIES VESTED WITH THE TRUST:

The Founder Trustee hereby declares that the sum of Rs. 2,000/- (Rupees Two Thousand Only) shall stand owned and possessed by the Trust and also any other capital moneys and /or properties which the trustees may from time to time acquire or receive by way of donations or receipts as may be accepted for the general purpose of the Trust or for any special or specific purposes connected with the objects of the Trust

All the funds of the trust and the income arising from the properties, assets, investments, deposits of any nature etc., of the trust funds, shall be applied for the purposes of the trust in such manner as the founder Trustees in consultation with the objectives of the Trust.

The trust and its funds shall ensure for the benefit of the public only and not for any private benefit of the Founder, Trustees or their relatives.

The Directors shall stand and be possessed of the settled property, being the original corpus and all additions thereto by way of income, gifts or otherwise (the total of which shall herein referred to as the 'trust funds') in trust for public charitable purposes subject to the terms, conditions and provisions of this document.





**4. FUNCTIONS OF THE BOARD OF TRUSTEES:**

The Trustees other than the Founder Trustee and Chairman shall hold office for a period of five years. The Founder-Chairman in consultation with the Trust Board may appoint and remove any Trustee in the larger interest of the Trust. Any vacancy arising in the office of the Trustee by reason of death, retirement and for other reasons shall be filled up by the Founder Trustee in consultation with other trustees whenever they desire if necessary during their life time. The Founder Trustee may appoint a suitable successor in his place as Founder Chairman. In the event of the Founder Trustee relinquishing the Office by reason of death or for any other reason, the successor nominated by the Founder Trustee Chairman shall discharge all the functions of the Founder Trustee-cum-Chairman including filling up the vacancies in the Trust or also removal of a Trustee if need be.

**5. MANAGEMENT OF THE TRUST:**

The day to day conduct and management of the Trust and its affairs shall be carried on by the Founder-Trustee-Chairman assisted and guided by the Board of Trustees.

**The Board of Trustees shall have the following powers:**

- a) To receive properties by way of gifts, donations, contributions and grants and other assets to the Trust

The Trustees shall have power in their discretion to accept, upon such terms as they may think fit, any donations or contributions of property of any kind which any person may be desirous of making to the trust.

Provided that the terms upon which such donations or contributions shall be accepted shall not in any way be inconsistent with or repugnant to the objects of these presents to be utilized only in furtherance of its objects.

Provided further the Directors shall, in their absolute discretion, be entitled to treat such donations or contributions or any part thereof as part of the corpus of the trust funds or to utilise such donations or contribution or any part thereof for the furtherance or fulfillment of the objects of the Trust.

- b) To purchase, take on lease, provide, erect, maintain, upkeep, construct and put up buildings, structures, institutions, hostels, rest-houses, hermitages, equipments etc., including the maintenance of live stock, cattle etc.
- c) To acquire all or any part of the understanding, good-will, proprietary rights, assets and liabilities of any other institution or co-operative in any manner with any individual or association or institution in order to achieve the objectives of the Trust
- d) To transfer any property or assets belonging to the Trust by way of sale or donate to any other body or institution whose objects are substantially the same as this Trust, with the Written permission of the Founder Trustees or their nominees



- e) To raise or receive any loan or such loans and advances as they may think fit and proper for the benefit of the Trust with the Written Consent of the Founder Trustee Chairman
  - f) To invest any money of the Trust, in such investment as may be thought proper to be held, sell or deal otherwise with such investments or change of the names as and when considered necessary and proper
  - g) To make and prescribe from time to time rules, bye-laws, regulations for carrying out the objectives of the objectives of the Trust and all other matters incidental thereto and also modify or amend such rules, bye-laws and regulations within the frame-work of the Trust
  - h) To do all other acts as may be necessary for carrying out the objects of the Trust
6. No individual Trustee shall burden the Estate of the Trust in any manner whatsoever either by borrowing the loan or offering the property as security or otherwise and if in spite of such restrictions if any Trustee does the same, he alone shall be personally responsible for discharge of such obligations. The property of the Trust as on today or acquired from time to time shall not be alienated for any reason, purpose or whatsoever but the property of the Estate could be burdened with an obligation to discharge the amount borrowed, if any, only for the improvement of the Trust and such borrowing shall not over burden the estate and must be capable of repayment with the assets of the Trust without the Trust property being dissipated.

## 7. ADMINISTRATION AND FINANCE

- a) To have complete and effective control over the management of the affairs of the Trust
- b) To open, run and close accounts with any Bank or Banks in the name of the Trust to operate such accounts , to pay and draw money from such accounts and otherwise deal with the same
- c) To appoint qualified Chartered Accountant for auditing of the accounts of the Trust. Such appointment shall ordinarily be for a period of one year and renewable at their discretion
- d) To nominate or remove any Trustee in consultation with the Board from the Office
- e) The bank account(s) will be operated any two of the following - Chairman, Vice-Chairman and Treasurer.
- f) While implementing and carrying out the various objects and activities of the Trust, the decision of the Founder Trustee shall be final and binding

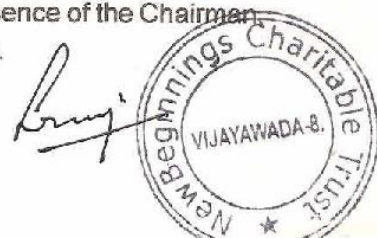


**8. THE FOUNDER TRUSTEE CHAIRMAN SHALL HAVE THE FOLLOWING POWERS:**

- a) To execute, become party to, to sign, acknowledge and register all deeds, agreements, writings to give effectual discharge for and on behalf of the Trust;
- b) To draw, make, accept, endorse, discount, negotiate, execute, cheques and bills of the exchange and negotiable instruments;
- c) To employ any person or persons in the office of the Trust; and to terminate or suspend any person or persons in the office of the Trust
- d) To institute, conduct, defend, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal, judicial or quasi judicial proceedings, claims, disputes for and on behalf of the Trust or Trustees and employees concerning the affairs of the Trust;
- e) To sign and verify Vakalatnama, plaints, Statements, affidavits or other proceedings before all courts, Governmental authorities, Tribunals, Tax-Authorities, Corporation or Municipal Authorities and also Quasi Governmental Authorities;
- f) To present the Trust in all proceedings, Civil, Criminal, Revenue Tax or Municipal and before all Authorities
- g) To maintain the minutes of the proceedings of the meetings and proper accounts for all the funds, moneys and assets and properties of the Trust. The accounts of the Trust shall be closed on the 31<sup>st</sup> day of March, every year.
- h) To do such other acts and deeds consistent with the powers conferred herein and such other acts authorized by the Board of the Trustees by a resolution
- i) The Founder Trustee and Trustees shall be entitled to takeover the ownership and /or management of any trust, charity or other body on such terms and conditions as may be thought fit by them provided that such trust or charities do not have any objects or purposes in contradiction so those of this trust
- j) The Founder Trustee and Trustees shall have power to frame such rules and regulations as they think fit with respect to the working of the trust for fulfillment of the purpose of the trust and for carrying out the objectives of the trust.

**9. PROCEEDINGS OF THE TRUST:**

- a) The Board of Trustees shall meet once a year or as often as necessary on the requisition of the major authority of the Trustees of the Founder Trustees or Chairman. The quorum for the meeting shall be three.
- b) The Founder Trustee or the Chairman of the Trustees shall normally preside over all the meetings of the Board of Trustees and in the absence of the Chairman any Trustee selected by the Board of Trustees will preside.



- c) Normally, the vote of majority present at the meeting shall prevail. In case of equal votes, the Chairman shall have the casting vote. But any resolution, if in the opinion of the Founder Trustee is inconsistent with the aims and objects of the Trust or its welfare; he can declare the same as null and void.
- d) The Board of Trustees shall also be competent to pass any resolution by circulation among them and this shall be ratified at the next meeting or the next adjourned meeting of the Board of Trustees.
- e) The Trustees may apply the funds of the Trust to the above said objectives entire by the Trust itself establishing, running or maintain such institutions or by making donation or contributions to other Trusts of the institutions for carrying out any of the above said objects.
- f) The Trust shall not carry out its activities anywhere out side India.
- g) The income of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be used for payment to the Trustees by way of profit or by any other means.
- h) The income of the Trust will be for the benefit of all irrespective of caste, religion, colour, sex etc.
- i) The Trust will not carry on any activity with the object of earning profit.

#### 14. DISSOLUTION:

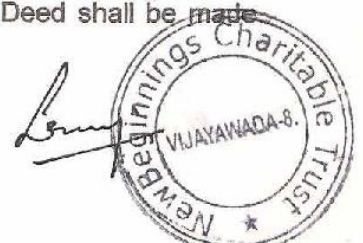
The General Body of the Trust shall have the power to dissolve the Trust by a two-thirds majority of its members

If at any time the objects of the Trust should become impossible of fulfilment or in the case of dissolution of winding up of the Trust the assets still remaining in the Trust after full satisfaction of all the liabilities of it, will be handed over to some other Trust having similar aims and objectives and having registered under Section 12A to which the provisions of the Section 80G (5) (3) of the Income Tax Act, 1961 do apply.

#### 15. AMENDMENTS:

Notwithstanding standing anything contain herein the Directors shall have power by deed inter vivo or such other documents as may be necessary to delete or amend any of the objects or provisions or any part of this deed if they are of the opinion that any part thereof are found contrary to the concept of public charity according to the income tax laws prevailing for the time being. The Directors shall, however, amend the objects of the trust only with the prior approval of the General Body of the Trust with a 75% majority approving it, and with the prior approval of the Commissioner of Income Tax, unless the Directors have chosen not to claim exemption as a public charity under tax laws .

No alterations, amendments, deletions or additions to the Trust Deed shall be made without the prior approval of the Commissioner of Income Tax.



It is hereby expressly declared that this Trust is Absolute and Irrevocable.

**DECLARATION**

It is declared that the activities of the Trust will be carried on strictly in accordance with Law of the Land. At present there is no immovable property to the trust.

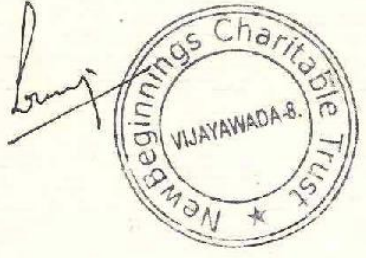

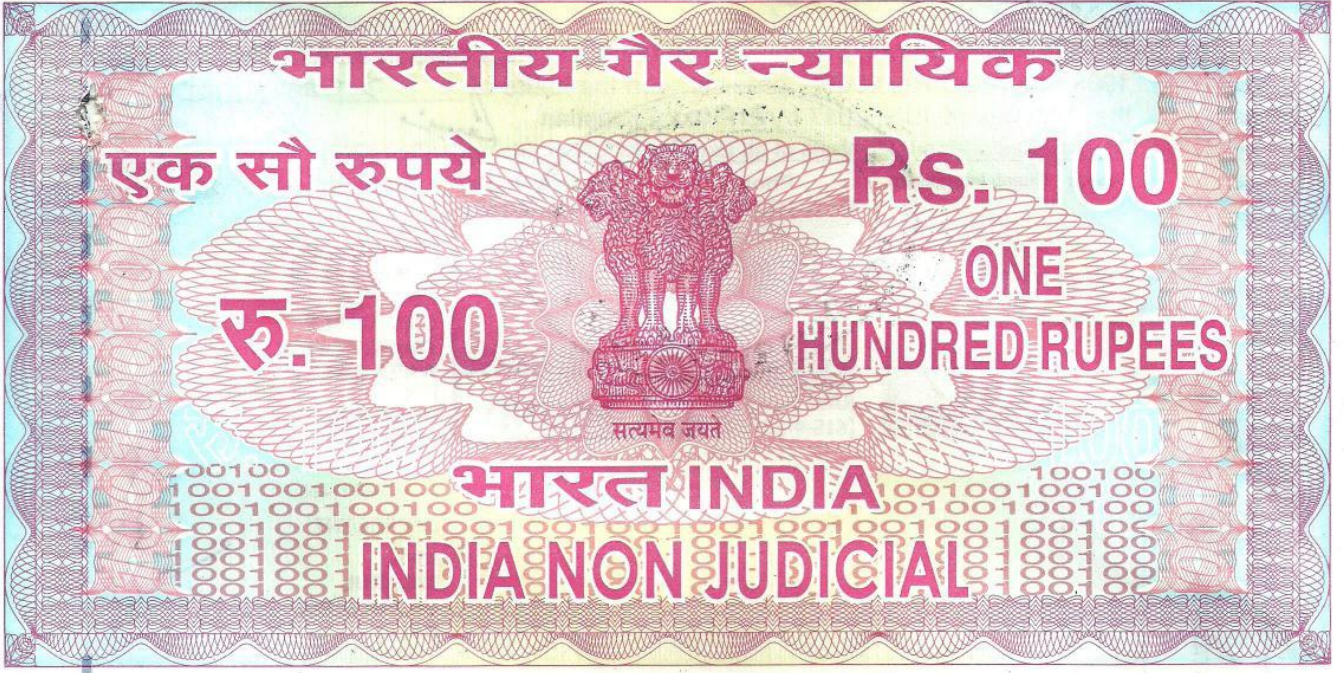

WHEREAS a public Charitable Trust by name 'NEWBEGINNINGS CHARITABLE TRUST' was brought into existence on 23.11.2009 by means of a Deed of Trust, registered as Document No.106 of 2009 of Book IV in the office of the District Registrar, Vijayawada (East).
